Articles of Incorporation of Boldridge Incorporated



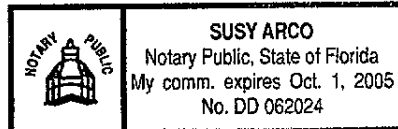
