

ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, Gretchen Roberson, being a fine of the second of t natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

#### ARTICLE I

# CORPORATE NAME

The name of this Corporation is POWER BIZ CONSULTANTS INC. The principal office and mailing address of the corporation is 113a3 Bonita Beach Road, Bonita Springs, Florida 34135.

#### ARTICLE II

#### DURATION

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

#### ARTICLE III

# **PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful business.

#### CAPITAL STOCK
