ARTICLES OF INCORPORATION OF
MARIE ALIXE KIMA, P.A.

1. Name. The name of the corporation is: MARIE ALIXE KIMA, P.A.
2. Purpose. The corporation may engage in the business of carrying on a practice of medicine and rendering professional medical services; provided however, the corporation may also invest its funds in real estate, mortgages, stocks, bonds or any other type of investments and may own real or personal property necessary for the rendering of such professional services.
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1000 shares of common capital stock with no par value. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of the transfer or levy on such shares.
4. Existence. The corporation shall have perpetual existence. The corporation shall commence existence on May 6, 2002.
