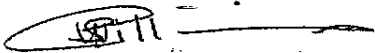

The name of the Corporation is **Magic Paint Ball, Inc.**

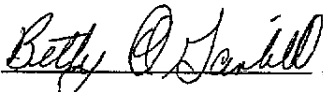
