

This letter is to inform you that the first notice I received instructing me to pay the annual report was July of this year. Unfortunately, I never received the original notice. When I received the notice in July, I immediately filled out the Uniform Business Report and wrote a letter explaining that I had never received the original notice (per the instructions in the booklet). I also enclosed a check in the amount of \$150.00, the original filing fee. According to my records, this check has cleared.
