Articles of Incorporation

I, THE UNDERSIGNED, do hereby associate myself for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

ARTICLE I - NAME

The name of the Corporation shall be:

BROWARD TRUCK & VAN SALES, INC., a Florida corporation

ARTICLE II - PURPOSE

- A. To carry on and engage in the purchase, sale, distribution, lease, and to otherwise deal in the wholesale and retail sale and purchase of all types of used motor vehicles, including trucks, vans, and utility vehicles and all accessories and parts related thereto; and to do all other acts which may be necessary and related thereto.
