ARTICLE I NAME

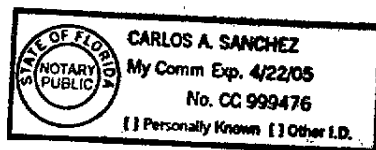


