**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida Corporation Act, adopts the following Articles of Incorporation:

Article I - Name

The name of this corporation is: McIntyre Exteriors, Inc.

Article II - Duration

This corporation shall have perpetual existence.


Article VIII - Indemnification
