1. Name.

The name of the Corporation is set forth above.

2. Principal Office and Registered Agent.

Its registered agent, registered office and principal office in the State of Florida is: James P. Hayes, 607 Garland Circle Indian Rocks Beach, Florida 33785.

3. Purposes.

The nature of the business or purposes to be conducted or promoted is the practice of law in the State of Florida.

4. Capital Stock.

The private property of the stockholders shall not be subject to the payment of corporate debts.

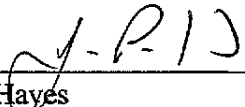

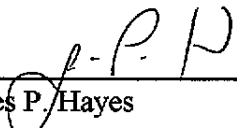
