The name of this corporation is C & F, Consulting, Inc.

ARTICLE II. DURATION



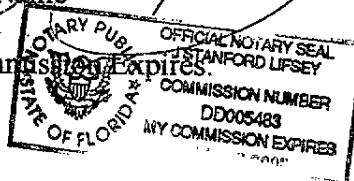
