**ARTICLES OF
INCORPORATION OF HOMETOWN GRAPHICS, INC.**

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME: The name of the corporation is **HOMETOWN GRAPHICS, INC.**

ARTICLE II

DURATION: The term of existence of this corporation is to be perpetual until dissolved by law.

ARTICLE III

PURPOSE: The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV

CAPITAL STOCK: The authorized capital stock of the corporation shall be one hundred (100) shares of common stock, with a par value of One Dollar (\$1.00) each. Said stock shall be issued by the Board of Directors for such consideration as they deem equivalent to the market value thereof. No shares of stock shall be issued for labor, services or in exchange for existing shares of stock of another corporation.

INITIAL DISTRIBUTION: The initial distribution of common stock of said corporation shall be fifty (100) shares of common stock to Dorothy Seiter.

ARTICLE V

INITIAL REGISTERED OFFICE: The street address of the initial registered agent of the corporation is 2132 Paddock Circle, Dunedin, Florida 34698.

ARTICLE VI

INITIAL REGISTERED AGENT: The initial registered agent of the corporation is Dave Seiter whose address is 2132 Paddock Circle, Dunedin, Florida 34698.

ARTICLE VII

DIRECTORS: The initial Board of Directors of the corporation shall consist of the one (1) members. The number of directors may be increased or decreased from time to time by the By-Laws of the corporation, but shall never be less than one (1). ARTICLE IX

DIRECTORS' POWERS: The directors of this corporation are authorized to make, alter and amend the By-Laws of the corporation; affix the salaries, if any, to be paid to the Officers and Directors of the corporation and to determine what, if any, dividends shall be declared and paid; set apart out of the funds of the corporation dividends any reserve or reserves for any

proper purpose, or to abolish any such reserve in a manner in which it was created. The corporation, by its By-Laws, may confer upon the Board of Directors, in addition to the foregoing and in addition to the powers and authorities expressly conferred upon it by the Statutes of Florida, any additional powers needed to govern said corporation. The Directors shall have the powers to hold their meetings and to keep one or more offices. In addition, the Directors shall have the power to keep copies of the books and ledgers of said corporation at such offices, except the original books and ledgers must be kept at the registered office of said corporation, or at such place or places as from time to time may be designated by the By-Laws or Resolution of the Board of Directors. Members of the Board of Directors may participate in regular Board meetings by conference, telephone or by other means as provided by Florida law.

ARTICLE X

INDEMNIFICATION: The corporation shall indemnify any Officer, Director or any former Officer or Director to the full extent permitted by law.

ARTICLE XI

AMENDMENT: This corporation reserves the right to amend or repeal any provisions contained in these Articles or any amendment thereto, and any and all rights conferred upon the shareholders is also subject to reservation.

ARTICLE XII

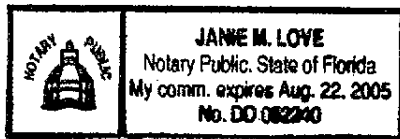
COMMENCEMENT OF EXISTENCE: The corporation shall commence its existence on the date of the filing of these Articles of Incorporation.

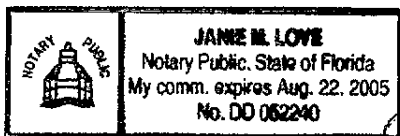
