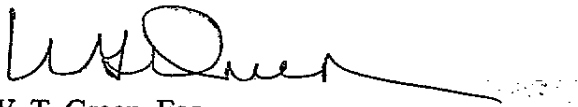

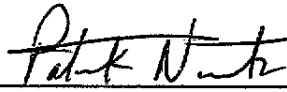

The Corporation shall indemnify any person to the fullest extent permitted by the Florida Business Corporation Act.

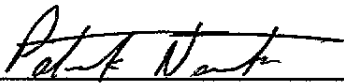

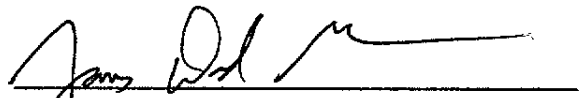
