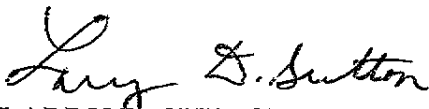

The undersigned, for the purpose of forming a professional service corporation under the laws of Florida, adopts the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is Mike Miller, P.A.

ARTICLE TWO

PRINCIPAL OFFICE

ARTICLE THREE

CORPORATE DURATION

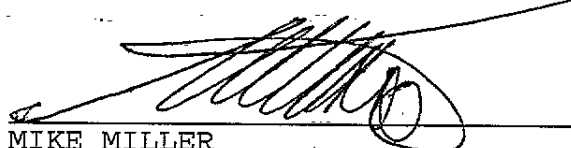
