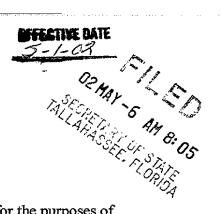

ARTICLES OF INCORPORATION

OF

CHOCTAW TITLE, INC.

ARTICLE I - NAME
