**ARTICLES OF INCORPORATION
OF
DYNAMIC DESIGNS BY DAVID, INC.**

I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be: DYNAMIC DESIGNS BY DAVID, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be:

7838 ALLSPICE CIRCLE WEST JACKSONVILLE, FL 32244

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE IV - PURPOSE


