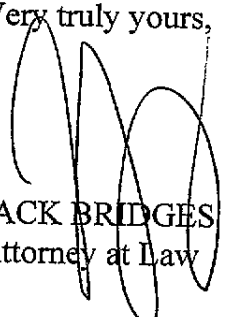

**ARTICLE VII**  
**Resolution of Disputes Between Shareholders**
