We, the undersigned, in order to form a corporation under and pursuant to the provisions of the Law of Florida for the purpose set forth below, hereby subscribe to these Articles of Incorporation.

**ARTICLE I - NAME**

**ARTICLE II - DURATION**

This corporation shall have perpetual existence.

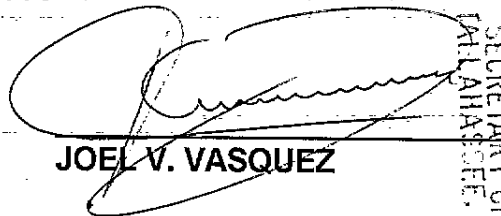
