

**ARTICLES OF INCORPORATION**

**OF**

**CHRISTIAN F. O'RYAN, P.A.**

**ARTICLE I – Name and Address**

The name of this corporation is CHRISTIAN F. O'RYAN, P.A.. The principal place of business and the mailing address for the corporation is: 2701 North Rocky Point Drive, Suite 930, Tampa, Florida 33607.

**ARTICLE II – Purpose**

The general purpose of the corporation shall be to engage in every aspect of the general practice of law. The professional services involved in the corporation's practice of law may be rendered only through its officers, agents and employees who are active members of The Florida Bar in good standing.

The corporation shall not engage in any business other than the practice of law; however, this corporation may invest its funds in real estate, mortgages, stocks, bonds and any other types of investments, and may own real and personal property necessary for the rendering of the professional services authorized hereby.

**ARTICLE III – Duration**

The corporation shall have perpetual existence.

**ARTICLE IV - Election**

The corporation hereby elects to be governed by the provisions of the Florida Professional Service Corporation Act.

**ARTICLE V – Capital Stock**

The corporation is authorized to issue 1,000 shares of common stock, which shall be designated as "Common Shares." The par value of each share of stock shall be One Dollar (\$1.00).

**ARTICLE VI – Initial Registered Office and Agent**

The street address of the initial registered office of this corporation is 2701 North Rocky Point Drive, Suite 930, Tampa, Florida 33607, and the name of the initial registered agent of this corporation at that address is CHRISTIAN F. O'RYAN.
