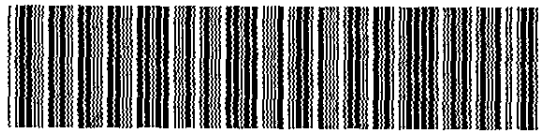

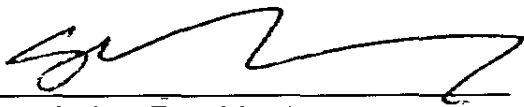
SECOND: The date of the adoption of these Articles of Dissolution is June 3, 2004.
