ARTICLES OF INCORPORATION OF MOUNTAIN REALTY, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned acting as incorporator, of a corporation under the Florida Business Corporations Act, hereby adopts the following Articles for such corporation.

ARTICLE I
