ARTICLES OF INCORPORATION ZMD USA, INC.

ARTICLE I. NAME

The name of this corporation is:

ZMD USA, INC.

ARTICLE II. PURPOSE

This corporation is organized for the following purposes:

To engage in any and all lawful business for which a corporation may be incorporated under the laws of Florida.

ARTICLE III. POWERS
