ARTICLES OF INCORPORATION FOR GET DOWN ENTERTAINMENT SERVICES INC.

The undersigned, desiring to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Florida, hereby certify its information as follows:

ARTICLE I

The name of the corporation shall be <u>GET DOWN ENTERTAINMENT</u> <u>SERVICES INC.</u>

ARTICLE II

The general nature of the business and objects and purposes proposed to be transacted, promoted, and carried on is promotion, production distribution, music and musician management, serving as agents and representatives, a variety of services related to the entertainment and music industry and to engage in any and all activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

The amount of the total authorized capital stock issued by the corporation is one thousand (100) shares of common stock having a par value of \$1.00 per share. There shall be no preferred stock.

All or any part of said capital stock may be payable either, in cash, property, labor, or services at a just valuation to be fixed by the Board of Directors, and judgement of such directors as to value shall, in the absence of fraud, be conclusive upon the stockholders and parties dealing with the corporation. The capital stock may be issued and paid for at such time or terms and conditions as the Directors may determine and the amount of the capital stock increased or decreased in the manner provided by law; provided, however, that the stock of the corporation shall be non assessable.

ARTICLE IV

The provisions of S. 607.108, F.S., relating to affiliated transactions, shall be inapplicable to this corporation.

ARTICLE V

The term of existence of this corporation shall be perpetual.

ARTICLE VII

The number of Directors of this corporation shall not be less than one (1) nor more than seven (7) as the same may be provided for by the by-laws of this corporation or amendments thereto. Until changed by the by-laws the number of Directors of this corporation shall be three.
