In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is **The Laundry Lady, Inc.**

ARTICLE II

The existence of the corporation shall begin on May 9, 2002.

ARTICLE III

The street address and mailing address of the principal office of the Corporation is 11751 S.W. Dallas Drive, Lake Suzy, Florida 34269.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares.
