ARTICLE I - NAME

The name of this corporation is CUTZ & DESIGNZ, INC.

ARTICLE II - ADDRESS

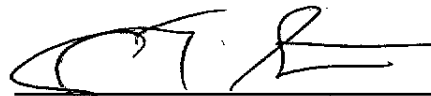
ARTICLE IX - BYLAWS
