### ARTICLES OF INCORPORATION

**OF** 

#### LADO FINANCIAL MANAGEMENT, INC.

Pursuant to Section 607.1001, Florida Statutes, the Articles of Incorporation of the abovenamed Corporation are amended as follows:

- 1. Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:
