### TALLANASSEE, FLORIDA ARTICLES OF INCORPORATION **OF**

Walty Walt Trucking, Inc.

#### ARTICLE I

The name of the Corporation is Walty Walt Trucking, Inc.

#### ARTICLE II

Its initial registered office and principal office in the State of Florida is 15909 Country Place, City of Tampa, County of Hillsborough. The name of the initial registered agent at such address is Walter Dunn Jr.

#### ARTICLE III

The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.
