I write to you to explain my misunderstanding concerning the UBR Annual Report and to ask that you please pardon my ignorance. Please waive, if at all possible, the penalty given to our one (1) year old corporation (incorporated on 5-7-2002).

We have an accountant who takes care of filing our IRS taxes at the end of the year. He pretty much coached us, my husband –Argel A. Cabrera- and me, on necessary steps to follow for our corporation, as we are new to all of this. I had understood (again, total misunderstanding and I sincerely apologize for this) that, because we have no employees at this time, we didn't need to file anything other than IRS taxes, our yearly local city and county occupational licenses, and Sales Taxes through the Department of Revenue. All of these are up-to-date. Hence, I didn't follow-up with anything else received in the mail because of my misunderstanding. And as ignorance has it, I didn't even open or read anything else thinking it unnecessary. This last time I actually opened it and read it because of the RED Writing: 'Notice of Administrative Dissolution or Revocation' and I thought: 'Yikes! What did I do wrong?'

Both my husband and I have our regular full time office jobs in Corporate America, and we manage New Bay Snacks & Drinks, Inc. on our spare time. We have no employees yet.
