

# ARTICLES OF INCORPORATION

OF





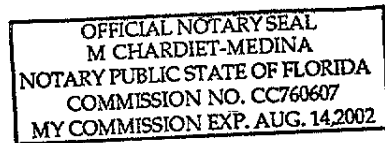
