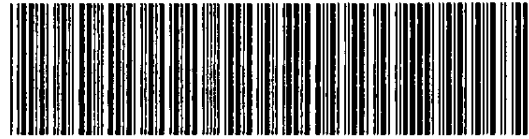

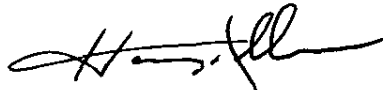

ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
SILVER ENTERPRISES ASSOCIATES, INC.

Pursuant to the provisions of Section 607.1006 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is SILVER ENTERPRISES ASSOCIATES, INC.

2. The following Amendment to the Articles of Incorporation was adopted by all of the Directors and all of the stockholders of the Corporation eligible to vote by the execution of a written statement manifesting their intention that such amendment be adopted, dated the 1st day of February, 2011, in the manner prescribed by Section 607.1006 of the Florida General Corporation Act:

Article III of the Articles of Incorporation is amended to read as follows:

ARTICLE III

The authorized capital stock which the corporation may issue, shall be fifty thousand (50,000) share of \$1.00 par value common stock, which shall be non-assessable and held, sold and paid for at such time and in such a manner as the Board of Directors may from time to time determine.

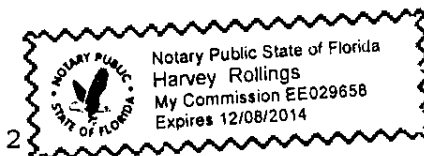
