ARTICLES OF INCORPORATION

THE UNDERSIGNED incorporator hereby forms a Professional Association under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be:

WYLIE T. SCOTT, M.D. P.A.

ARTICLE II. PRINCIPAL OFFICE

The address of the principal office of this Corporation shall be 12 Gate House Road, Sea Ranch Lakes, Florida 33308, and the mailing address of the Corporation shall be the same.

ARTICLE III. PURPOSE

This corporation is organized for the following purposes:

A. To engage in the practice of medicine as a professional corporation.

B. To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and to do every other act incidental to the corporate purposes which is not forbidden under the laws of the United States, the State of Florida or any other state, country, or territory in this nation or by the provisions of these articles of incorporation.
