FIRST The name of this corporation is Team Porkpie, Inc.

SECOND. Its registered office in the State Of Florida is to be located at 6508 Bimini Court, Apollo Beach, Florida 33572, County of Hillsborough. The registered agent in charge thereof is Donald J. Geist, 6508 Bimini Court, Apollo Beach, Florida 33572.

THIRD. The nature of the business and, the objects and purposes proposed to be transacted, promoted, and carried on, are to do any or all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world.
