

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE I – NAME

The name of the corporation is KATHLEEN M. THOMSEN, INC.

ARTICLE II – PRINCIPAL OFFICE

The principle place of business and mailing address of this corporation shall be:

ARTICLE VII – PURPOSE


**The purpose for which the corporation is organized is to engage in

The pre-emptive right of any holder is determined by the ratio of the authorized share of common stock held by the holder to all shares of common stock currently authorized.


