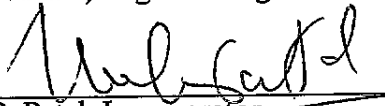
- (A) To elect or appoint officers and agents of the Corporation and to fix their compensation;

The Corporation shall have perpetual existence.

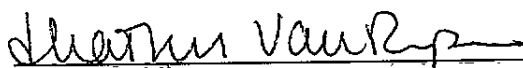
