The undersigned subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a professional association for profit under the laws of the state of Florida.

## ARTICLE I - NAME

The name of the corporation is DAVID D. EGE, P.A.

# ARTICLE II -NATURE OF BUSINESS
