The undersigned for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is: Romulex Export Inc.

**ARTICLE II
COMMENCEMENT AND DURATION**

This corporation shall commence business as of the filing of these Articles of Incorporation. Its existence shall be perpetual.

**ARTICLE III
PURPOSE**

This corporation may transact any and all lawful business for which corporations may be incorporated under the Florida Corporations Act. The principle business activity shall be export of tools and equipment.

**ARTICLE IV
CAPITAL STOCK**

The corporation shall issue 500 shares of capital stock at a par value of \$1.00 Per share. Of which 500 shares are issued to Romulo Villafuerte at the time of incorporation by the state of Florida.

**ARTICLE V
MANAGEMENT**

This corporation shall have no Board of Directors and all of the corporate powers shall be exercised by, and all the business affairs of the corporation shall be managed by the officer/s of the corporation.

ARTICLE VI
VOTING RIGHTS

The stock holder/s can vote for the election of the officers of the corporation.

ARTICLE VII
SPECIAL MEETINGS – CALL OF

Special meetings of the members may be called at any time, for any purpose by an officer of the corporation or by 20% of all members.

ARTICLE VIII
MEMBERS RIGHTS & RESERVATIONS OF POWER
TO ADOPT, AMEND, AND REPEAL BY-LAWS

The power to make, alter, or amend and repeal the by-laws of the corporation shall be reserved to the Stockholder/s of the corporation.
