**ARTICLE I

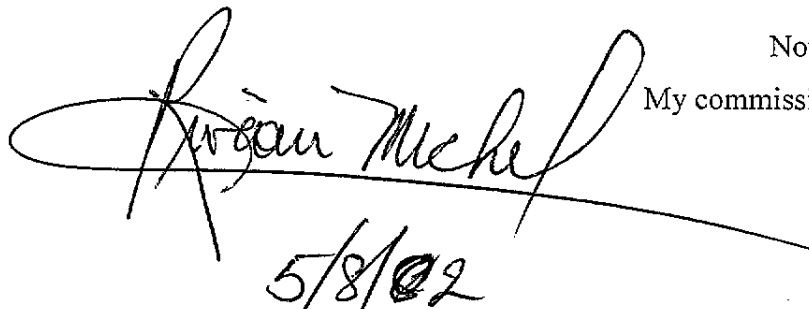
