**ARTICLES OF INCORPORATION  
OF  
JOSEPH AUER IV/BOOTH COBBLESTONES, INC.**

ARTICLE I: The name of the corporation shall be **JOSEPH AUER IV/BOOTH COBBLESTONES, INC.**

ARTICLE II: The purpose of the corporation is to engage in any lawful activity for which a corporation may be organized under the laws of the State of Florida.

ARTICLE III: The duration of the corporation shall be perpetual.


