**ARTICLE I  
NAME**

The name of this Corporation is PORTOBELLO TRADING COMPANY, and its mailing address is c/o Aileen Ortega, P.A., 2420 Coral Way, Miami, Florida 33145.

**ARTICLE II  
NATURE OF BUSINESS**

This Corporation is being formed for the following purposes:

Further, the power to adopt, alter, amend or repeal the By-Laws shall be vested in the Board of Directors of this Corporation.

ARTICLE XI  
POWERS

This Corporation shall have all of the corporate powers enumerated in the Florida Business Corporation Act, as amended from time to time.

ARTICLE XII  
DIVIDENDS

Dividends payable in shares of any class may be paid to the holders of shares of any other class.

ARTICLE XIII  
INDEMNIFICATION

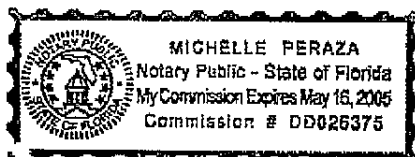


