ARTICLES OF INCORPORATION OF LYNNE AND ALEC ENTERPRISES, INC.

The undersigned incorporator, being one (1) in number, for the purpose of becoming a body corporation hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be LYNNE AND ALEC ENTERPRISES, INC., hereinafter referred to as the "Corporation." The registered office and principal place of business of this corporation shall be at \$700 N Et St., Pensacola, Florida 32501.

ARTICLE II: DURATION

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Secretary of State.

ARTICLE III: PURPOSE

In provision the number of members of the Board of Directors shall consist of one member until the first annual stockholders' meeting.

They shall hold office for the first year of service of the corporation until successors are elected.
