The undersigned, acting as incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME

The name of the Corporation is **YVETTE BASSETTI CORPORATION**.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the Corporation's principal office is 4301 N.E. 18th Avenue, Oakland Park, Florida, 33334, and the mailing address of the Corporation is the same.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of Florida.

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue Ten Thousand (10,000) shares of common stock, at One Dollar (\$1.00) par value per share.

ARTICLE V - INITIAL REGISTERED AGENT AND OFFICE
