Articles of Incorporation

The undersigned for the purpose of forming a corporation under the Florida General Act, so you hereby adopt the following articles of incorporation:

Article one

The name if the corporation is Internal Medicine & Pediatrics, P.A.

Article Two

The duration of the corporation is perpetual.

Article Three

The general purposes for which the corporation is organized are:
