The name and address of the initial director of the corporation is Lisa Dunnohew, 6710 NW 81st Court, Parkland, Florida 33067.


ARTICLE IX

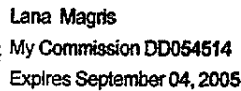


