We, the undersigned, subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate ourselves to form a Corporation under the Laws of the State of Florida.

ARTICLE I

NAME

The name of this Corporation is: M.A.J. ENTERPRISES, INC.

ARTICLE II

NATURE OF BUSINESS

The general nature of business and the object and purposes to be transacted and carried on are: ANY LEGAL ACTIVITY UNDER THE LAWS OF THE STATE OF FLORIDA. And, in general, to carry on any other business whatsoever in connection with the foregoing or which is calculated directly or indirectly to promote the interest of the corporation or to enhance the value of its properties.

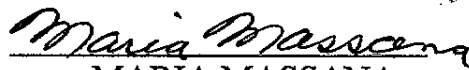
