OF

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be ROCKY'S PROFESSIONAL PAINTING, INC.

The address of the principal office of this corporation shall be 948-C Wind Ridge Ct., Port Orange, FL 32124, and the mailing address is the same.

ARTICLE II

NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 50 shares of common stock having no par value per share.

ARTICLE IV

REGISTERED OFFICE AND AGENT




AMENDMENT OF ARTICLES


