ARTICLES OF INCORPORATION

of

ARTICLE I. NAME AND ADDRESS

The name of this corporation is JDQ, Inc., and the address of the corporation shall be 5340 Central Avenue, St. Petersburg, FL 33707.

ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

In accordance with Section 607.167 Florida Statutes, the date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.
