#### ARTICLES OF INCORPORATION

OF

## PERDIDO RIVER CANOE RENTALS, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida.

# ARTICLE I

The name of this corporation is PERDIDO RIVER CANOE RENTALS, INC.

#### ARTICLE II

The general nature of the business to be transacted by this corporation is:

- (a) To engage in the commercial rental of canoes including, but not limited to, each and every aspect of the commercial, retail and wholesale aspect and phase of a canoe rental business as well as for the purpose of engaging in and transacting all lawful business for which corporations may be incorporated under the Florida General Corporation Act and to do such other things as are incidental to the purposes of the corporation or necessary and desirable in order to accomplish them.
- (b) To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and invest in, trade in, deal in and with goods, wares and merchandise; real and personal property, and services of every class, kind and description: except that it is not to conduct a

banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, fraternal benefits society, state fair or exposition.

- (c) To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses, in the State of Florida and in other states and counties.
- (d) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence or indebtedness, and execute such mortgages, transfers or corporate property or other instruments to secure the payment of corporate indebtedness as required.

- (e) To purchase the corporate assets of any other corporation ad engage in the same or other character of business.
- (f) To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the share of the capital stock of, or any bonds, securities or other evidence of indebtedness created by any other corporation in the State of Florida or any other state or government, and while the owner of such stock, to exercise all the rights, power and privileges of ownership, including the right to vote such stock.
- (g) To do all and everything necessary and proper for the accomplishment of the objectives enumerated in its Articles of

Incorporation or any amendment thereof or necessary or incidental to the protection and benefit of the corporation, and in general to carry on any lawful business necessary or incidental to the attachment of the object of the corporation whether or not such business is similar in nature to the objects set forth in the Articles of Incorporation of such corporation or any amendment thereof.

# ARTICLE III

### Capital Stock

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock, with a par value of One (\$1.00) Dollar per share, all of which when issued shall be fully paid and non-assessable.

#### ARTICLE IV

The amount of capital with which this corporation will begin business is One Thousand and No/100 (\$1,000.00) Dollars.

# ARTICLE V

# Term of Existence

This corporation is to exist perpetually.

# ARTICLE VI

This initial Post Office address of the principal office of this corporation in the State of Florida is 330 Deerfoot Lane,

Cantonment, Florida 32533.

The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

#### ARTICLE VII

This corporation shall not have less than one, nor more than nine Directors. The number of Directors may be increased or diminished from time to time by the By-Laws adopted by the shareholders, but shall never be less than one.


