ARTICLES OF INCORPORATION OF INC. QUALITY MARBLE & TRAVERTINE, INC.

The undersigned, acting as incorporator of a Corporation pursuant to chapter-617, Florida Status, adopt(s) the following Articles of Incorporation of such corporation.

ARTICLE I. NAME

The name of the corporation shall be:

QUALITY MARBLE & TRAVERTINE, INC.

ARTICLE II. NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of America and the State of Florida and any other state country or territory. Business activities shall include but not limited to Import Export of Natural Marketing Stones, Real Estate, Transportation, Equipment leasing, Sales and marketing of services of all kind and any other things.

ARTICLE III. CAPITAL STOCK
