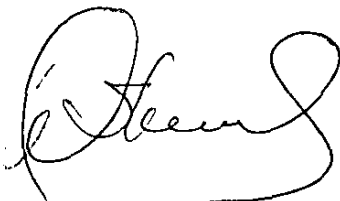
We therefore sent in the paperwork and they are still showing as dissolved.
