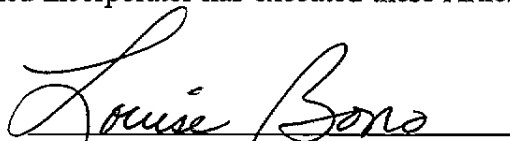
ARTICLE IX
