ARTICLE I - NAME

The name of this Corporation is Bubble Bee Car Wash, Inc.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence. The
Corporation shall commence existence on May 14, 2002.

ARTICLE III - PURPOSE

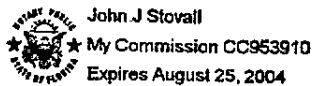
